I RECEIVED A LETTER FROM [OTHER FIRM EMPLOYEE], SENIOR COMPLIANCE ANALYST WITH ING FINANCIAL PARTNERS ON MAY 17, 2007 ASKING ME TO RESPOND TO AN "INQUIRY" REGARDING MY CLIENT'S PAPERWORK. I SUBMITTED MY RESPONSE TO THAT LETTER THE SAME DAY. BY THE TIME OF THE INQUIRY I HAD ALREADY MADE THE DECISION TO LEAVE ING FINANCIAL PARTNERS AND GO TO BRECEK & YOUNG ADVISORS, INC. DURING THE WEEK LEADING UP TO JUNE 13, 2007 (THE DAY I RESIGNED FROM ING FINANCIAL PARTNERS) I HAD MANY TENSE CONVERSATIONS WITH [MANAGING DIRECTOR], MANAGING DIRECTOR OF ING FINANCIAL PARTNERS WHERE I VERBALIZED MY DISSATISFACTION WITH ING FINANCIAL PARTNERS AS A FIRM. DURING OUR FINAL TELEPHONE CONVERSATION ON JUNE 13, 2007, IT WAS [MANAGING DIRECTOR] WHO SUGGESTED TO ME THAT I RESIGN. SINCE I HAD INTENDED TO RESIGN ANYWAY, I WENT AHEAD AND SUBMITTED MY RESIGNATION THAT DAY.
