IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

ALL ACCOUNTS WERE DISCLOSED TO PAINWEBBER AT THE TIME OF MY HIRING USING THE "NEW HIRE OUTSIDE BROKERAGE ACCOUNT QUESTIONNAIRE" AND INCLUDED A REQUEST TO MAINTAIN CERTAIN MANAGED, DISCRETIONARY ACCOUNTS OUTSIDE THE FIRM IN COMPLIANCE WITH PAINWEBBER POLICY ON OUTSIDE ACCOUNTS. IMMEDIATELY AFTER BEING INFORMED BY THE COMPLIANCE DEPT. THAT ADDITIONAL PROCEDURES WERE REQUIRED TO BE FOLLOWED, I DID AS REQUESTED. ALL OUTSIDE ACCOUNTS EVENTUALLY RECEIVED WRITTEN PERMISSION TO REMAIN OUTSIDE PAINWEBBER. I WAS TOLD BY MY MANGER THAT, WHILE UNFORTUNATE, IT WOULD NOT BE A MAJOR ISSUE. SUBSEQUENTLY, AFTER THE INTERNAL AUDIT DEPT. NOTED THAT THE APPROVALS WERE NOT RECEIVED ON A TIMELY BASIS IT WAS CITED AS A REASON FOR MY TERMINATION. PAINWEBBER ALLEGED THAT THIS WAS A VIOLATION OF FIRM POLICY BUT IN THE INTEREST OF BEING CONSERVATIVE I HAVE RESPONDED YES TO 23J(1).
