IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

IT APPEARS THAT DUE TO THE FIRM'S MISUNDERSTANDING OF THE PROCESS OF MIGRATING TO ELECTRONIC FILING, KEENE AND ASSOCIATES FAILED TO MAKE THE INVESTMENT ADVISER REPRESENTATIVE TRANSITION FILING AND FILE THE U-4 FORM VIA THE CRD/IARD SYSTEM FOR MR. KEENE. ALL DURING THIS PERIOD,



MR. KEENE MET THE QUALIFICATIONS REQUIRED FOR AN INVESTMENT ADVISER REPRESENTATIVE UNDER THE TEXAS SECURITIES ACT. MR. KEENE RESPONDED PROMPTLY TO THE NOTICE FROM THE TEXAS STATE SECURITIES BOARD AND SUCCESSFULLY APPLIED FOR REGISTRATION AS QUICKLY AS POSSIBLE.
