### Customer Dispute

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. **Allegations:** IN EARLY NOVEMBER 2000, I HAD A TELEPHONE CONVERSATION WITH [CUSTOMER] REGARDING THE MERGER BETWEEN BIOMATRIX AND GENZYME. UNDER THE MERGER AGREEMENT, EACH OUTSTANDING SHARE OF BIOMATRIX COMMON STOCK COULD BE CONVERTED INTO THE RIGHT TO RECEIVE CASH, STOCK OR A COMBINATION OF CASH AND STOCK, SUBJECT TO PRORATION, AT THE HOLDER'S OPTION. DURING THAT CONVERSATION, [CUSTOMER] CONFIRMED TO ME THAT HE HAD RECEIVED A COPY OF THE PROXY FROM BIOMATRIX EXPLAINING THE MERGER. HE FURTHER INDICATED TO ME THAT HE HAD READ THE PROXY AND UNDERSTOOD THE VARIOUS OPTIONS OFFERED IN THE PROXY. [CUSTOMER] DID NOT PLACE AN ORDER WITH ME DURING THE INITIAL CONVERSATION. I CALLED HIM IN EARLY DECEMBER TO GET A DECISION ON WHICH OPTION OR OPTIONS HE HAD CHOSEN. [CUSTOMER] INSTRUCTED ME VIA HIS ASSISTANT, HARRIET MOORE, THAT HE WISHED TO TENDER 50% IN CASH AND 50% IN STOCK FOR HIS PERSONAL ACCOUNT (AND TO TENDER FOR CASH 100% OF THE SHARES IN THE PENSION ACCOUNT). BASED ON THESE INSTRUCTIONS, I EXECUTED HIS INSTRUCTIONS ON DECEMBER 5TH, 2000 BY TENDERING 50% OF HIS POSITION UNDER THE CASH OPTION AND 50% UNDER THE STOCK OPTION (AND 100% OF THE PENSION SHARES UNDER THE CASH OPTION). AFTER THE PRICE OF THE NEW STOCK [CUSTOMER] RECEIVED BEGAN TO FALL IN DECEMBER AND EARLY JANUARY 2001, [CUSTOMER] COMPLAINED THAT I HAD FAILED TO EXECUTE HIS NOVEMBER 2000 INSTRUCTIONS PROPERLY. HE NOW CLAIMS THAT HE INSTRUCTED ME TO SELL 28.3% OF THE 54,000 SHARES IN HIS PERSONAL ACCOUNT FOR \$37.00 PER SHARE



AND TO SELL AS MANY ADDITIONAL SHARES AT \$37.00 AS AVAILABLE UP TO A MAXIMUM OF 50% OF THE SHARES HE OWNED IN HIS PERSONAL ACCOUNT, BUT RETAINING 50% IN THE GENZYME NEW STOCK BECAUSE HE WANTED EXPOSURE TO THAT NAME.

AFTER INVESTIGATION, MORGAN STANLEY DETERMINED THAT I HAD ACTED PROPERLY UPON RECEIVING [CUSTOMER]'S INSTRUCTION AND THAT [CUSTOMER]'S INSTRUCTION TO TENDER 50% CASH AND 50% STOCK WAS CARRIED OUT TO THE BEST OF OUR ABILITY GIVEN THE OPTIONS AVAILABLE IN THE MERGER. HOWEVER, TO AVOID THE TIME, BUSINESS DISRUPTION, EFFORT AND EXPENSE OF POSSIBLE PROTRACTED ARBITRATION, MORGAN STANLEY AND [CUSTOMER] HAVE RESOLVED THIS MATTER. MORGAN STANLEY AGREED TO PAY [CUSTOMER] \$128,541.03 IN EXCHANGE FOR A RELEASE.
