What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: CLIENT ALLEGES UNSUITABLE INVESTMENT RECOMMENDATIONS. CLIENT ENGAGED RR AND HER RIA FIRM TO PROVIDE DISCRETIONARY ASSET MANAGEMENT ON 1/18/00, WITH A SELF STATED INVESTMENT OBJECTIVE OF AGGRESSIVE GROWTH. CLIENT HAD A HISTORY OF AGGRESSIVE GROWTH STRATEGY AND NO NEED FOR CURRENT INCOME FROM HIS INVESTMENTS. CLIENT BECAME UNHAPPY WITH THE PERFORMANCE OF THE PORTFOLIO AND NOTIFIED RIA AND RR ON 11/28/00. CLIENT INFORMED RIA AND RR THAT HE HAD ADOPTED A STRATEGY OF SELLING INVESTMENTS WHEN THEY DROPPED BY MORE THAN 10% IN VALUE AND WAS DISGRUNTLED WHEN RR AND RIA WOULD NOT EMPLOY HIS SELF-IMPOSED INVESTMENT POLICY. RIA SUBSEQUENTLY TERMINATED CLIENT AGREEMENT ON 12/21/00.

CLIENT DID NOT SPECIFY ALLEGED AMOUNT OF DAMAGES BUT IN HIS COMPLAINT INDICATED THAT AT 04/01/00 THE MARKET VALUE OF HIS PORTFOLIO WAS APPROXIMATELY \$2.0 MILLION AND AT THE TIME HIS ADVISORY RELATIONSHIP WAS TERMINATED THE VALUE HAD DROPPED TO \$1.3 MILLION. BASED UPON THAT SIGNIFICANT DIFFERENCE IN PORTFOLIO VALUES, BIRCHTREE BELIEVES CLIENT WOULD HAVE SOUGHT COMPENSATORY DAMAGES IN EXCESS OF \$5,000.
