IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Allegations: THE CLIENT STATES THAT HE WAS NOT TOLD AT THE TIME OF HIS ORIGINAL PURCHASE THAT AMERICAN FUNDS HAS, WHAT HE REFERS TO AS, A "SIT-OUT" CLAUSE. HE STATED THAT HE WAS INFORMED BY HIS IR THAT WHEN LIQUIDATING FIVE AMERICAN FUNDS HE HAD A 90 DAY WINDOW FOR REPURCHASE WITHOUT HAVING TO PAY FEES IF THE PROCEEDS WERE PLACED INTO A JONES MONEY MARKET. THE CLIENT STATES HAD HE KNOWN THIS HE WOULD HAVE SOLD QUICKER AND NOT WAITED UNTIL THE LOSSES WERE SO SEVERE. HE ALSO STATES THAT A BROKER FROM ANOTHER FIRM ADVISED IF HIS FUNDS WOULD HAVE BEEN PLACED INTO AN AMERICAN FUNDS MONEY MARKET THE TIME WOULD HAVE BEEN UNLIMITED. CLIENT IS ALSO UNHAPPY WITH THE RECENT FEE RESTRUCTURING. THE CLIENT MAKES NO SPECIFIC CLAIMS.

A PORTION OF THE FUNDS WERE SOLD ON 7/19/02. ON 8/20/02 THE CLIENT BOUGHT BACK IN TO AMERICAN FUNDS WITH NO UPRFRONT SALES CHARGE. IT APPEARS AS THOUGH THE FINANCIAL ADVISOR'S PRIMARY FOCUS HAD THE CLIENT'S BEST INTEREST IN MIND AND WAS ENCOURAGING THE CLIENT TO REMAIN INVESTED AS THIS WAS INTENDED AS A LONG TERM INVESTMENT. NO ADJUSTMENTS TO BE MADE AT THIS TIME.
