What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement Advisor Rep. Lovett is the current County Judge of San Jacinto County, TX. On April 23, 2018, he was charged with felony burglary (entered the Court Clerk's office with a key), felony tampering with a governmental record (meeting agenda that he created) and misdemeanor forgery (use of Court Clerk's signature stamp for the meeting agenda). The alleged violations took place on or about July 7, 2017 and charges appear to be politically motivated, being made less than a month before Judge Lovett's run-off election. Lovett was found not guilty on all charges.



Customer Dispute

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator.
