<b>Broker Statement</b>	The registered representative adamantly denies breaching any fiduciary duty owed to her customer. The registered representative and her family, including her minor son, maintained a close relationship with the customer for many years prior to her untimely death. The customer voluntarily and willingly made the decision to list the



registered representative's son as a beneficiary. The registered representative later disclaimed any and all interest in the customer's estate on behalf of her minor son (including the LPL account) to confirm the lack of any wrongdoing and avoid the suggestion of any improprieties.
