**Broker Statement** Mr. Weis believes the above disclosure regarding resignation "after solicitation of a restricted security" is false and misleading. At the request of a client, Mr. Weis sent educational literature (news articles) regarding certain types of Bitcoin ETFs, but did not solicit any purchase/transaction. Consistent with his responsibilities as a financial advisor, he simply advised his client to research those complex products before making any investment decision. Additionally, the fact that Mr. Weis' communications on this matter were under review was unknown to Mr. Weis at the time he made his decision to leave his prior firm and, accordingly, was not a



factor in his decision to leave, which was made for other unrelated reasons.
