What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: FROM 12/23/2009 TO 02/23/2011 CLIENT INDICATES THE FINANCIAL ADVISOR CONVINCED HIM TO SELL CERTAIN INVESTMENTS AND ESTABLISH AN ADVISORY SOLUTIONS ACCOUNT. CLIENT STATES HE HAD RESERVATIONS ABOUT THE PROGRAM, BUT DID AGREE TO IT. CLIENT ALLEGES THE FINANCIAL ADVISOR INFORMED HIM HE WOULD DO MUCH BETTER IN THE PROGRAM AND THAT ALL OF HIS "OLD FUNDS" WERE NOT VERY GOOD. CLIENT STATES HE KEPT TRACK OF HOW HIS OLD FUNDS WOULD HAVE PERFORMED COMPARED TO ADVISORY SOLUTIONS AND HIS OLD FUNDS WOULD HAVE OUTPACED THE PROGRAM BY APPROXIMATELY \$100,000.00. HE CONTACTED THE FINANCIAL ADVISOR ABOUT A \$17,000 WITHDRAWAL, BUT THE FINANCIAL ADVISOR DID NOT REPLY. THE CLIENT DISCOVERED THIS WAS A REBALANCING ACTIVITY IN THE PROGRAM. THE CLIENT STATES HE WAS QUESTIONED IF HE HAD TAKEN INTO ACCOUNT THE \$91,000 HE HAD WITHDRAWN FROM THE ACCOUNT. CLIENT CLAIMS THE FINANCIAL ADVISOR COST HIM \$150,000.00.

THE CLIENT AGREEMENT REQUIRES ANSWERS TO VARIOUS QUESTIONS RELATED TO A CLIENT 'S INVESTMENT OBJECTIVES, TIME HORIZON FOR INVESTING AND RISK TOLERANCE. THE FINANCIAL ADVISOR EXPLAINED THE ADVISORY SOLUTIONS PROGRAM WAS A RELATIVELY NEW PROGRAM AND THE HYPOTHETICAL THE FINANCIAL ADVISOR PROVIDED TO THE CLIENT ILLUSTRATED HOW A PORTFOLIO SIMILAR TO THE ONE THE CLIENT TRYING TO BUILD MIGHT PERFORM. DURING THE TIME THE FINANCIAL ADVISOR SERVED THE CLIENT'S INVESTMENT NEEDS, IT APPEARS HE RECEIVED MULTIPLE E-MAILS FROM THE CLIENT RELATED TO VARIOUS INVESTMENTS AND RECOMMENDATIONS MADE BY ANOTHER INDIVIDUAL.
