IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: Time Frame: March 23, 2012 to June 18, 2018 The client's attorney alleges the investment was an aggressive and speculative investment specifically designed to be held for a short period of time, and therefore was unsuitable for conservative investors looking for long term growth from their accounts. The client's attorney further alleges the investment was described as a plain vanilla investment and never disclosed the investment was designed as a short term trading strategy. The client's attorney finally alleges the Financial Advisor failed to follow instructions letting aggressive and speculative investments in the account.
