**Broker Statement** I DENY THE ALLEGATIONS. I CONTACTED CLIENTS IN 8/06 TO DISCUSS THEIR ACCOUNT, AS I REGULARLY DO. A MEETING WAS SCHEDULED FOR 1/07; WE REVIEWED THE CLIENTS' RISK TOLERANCE, TAX BRACKET, TIME HORIZON, AND INVESTMENT EXPERIENCE. BASED UPON INFO PROVIDED, THE CLIENTS WERE EXPERIENCED INVESTORS. I RECOMMENDED THE CLIENTS INVEST IN THE FRANKLIN CA TAX FREE INCOME FUND C, WHICH WAS AGREED TO BY CLIENTS. I EXPLAINED THAT THIS WAS A MUTUAL FUND THAT INVESTED IN CA MUNI BONDS; THE PRINCIPAL WILL FLUCTUATE IN VALUE; WE DISCUSSED THE DIFFERENCES BETWEEN A/C SHARES, HIGHER MGMT FEES, AND SALES CHARGES. THE CLIENTS SIGNED THE REQUIRED DISCLOSURE DOCUMENTS AND UNDERSTOOD THEY WERE INVESTING IN A MUTUAL FUND THAT FLUCTUATES IN VALUE. THE CLIENT CONTACTED ME IN 6/07; WE DISCUSSED HIS CONCERNS THAT FUND VALUE HAD GONE DOWN, EVEN THOUGH HE WAS EARNING A MONTHLY DIVIDEND. I RECOMMENDED HE STAY WITH THE FUND; CLIENT WANTED TO MOVE HIS ASSETS. WE DISCUSSED THE SALES CHARGE AND EXCHANGING THE ASSETS WITHIN THE FUND FAMILY. THE CLIENT CHOSE THE FLOATING RATE FUND (PAYING A HIGHER DIVIDEND). IN 8/07, THE CLIENT WAS CONCERNED THAT ACCOUNT HAD DROPPED IN VALUE AND DIDN'T WANT TO LOSE ANYMORE VALUE, THE ASSETS, AS DIRECTED BY CLIENT, WERE TRANSFERRED TO MONEY MARKET FUND; HE WOULD LIQUIDATE THE ASSETS ON THE YEAR ANNIVERSARY. ON 1/4/08, CLIENT REQUESTED THE LIQUIDATION OF FUND. THE CLIENT SIGNED REQUIRED DOCUMENTATION & WANTED TO KNOW IF HIS WIFE WAS REQUIRED TO SIGN TRANSFER FORM.
