What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

ALTHOUGH THE ATTORNEY'S LETTER MAKES NO



SPECIFIC DEMAND AS TO THE DOLLAR AMOUNT AT ISSUE, MIDSOUTH CAPITAL, INC. ESTIMATES THE UNREALIZED MARKET RELATED LOSSES IN [CUSTOMER'S] ACCOUNT ARE APPROXIMATELY \$40,000. THERE HAS BEEN AN INDUSTRY-WIDE MARKET DOWNTURN SINCE HER INVESTMENT WAS MADE IN JUNE 2008. THE ATTORNEY'S LETTER MAKES NO SPECIFIC ASSERTIONS OF WRONGDOING OR IMPROPRIETY, BUT CONSISTS ENTIRELY OF STATEMENTS OF HIS OPINION THAT UNSPECIFIED ACTIONS BY THE REPRESENTATIVE AMOUNTED TO MISREPRESENTATIONS AND WERE FRAUDULENT.
