IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

CLAIMANT ALLEGED THAT WELLS FARGO AND I FAILED TO SUPERVISE A WELLS FARGO BROKER, JAY ROGERS. MR. ROGERS APPARENTLY RECOMMENDED TO CLAIMANT IN MARCH 2000 THAT HE INVEST A SMALL PERCENTAGE OF HIS ASSETS IN THE STOCK AND OPTION MARKETS. CLAIMANT LOST MONEY IN THE ENSUING MARKET CORRECTION. THE PANEL ORDERED THAT I, WELLS FARGO, AND MR. ROGERS BE JOINTLY AND SEVERALLY LIABLE TO CLAIMANT FOR \$120,000, APPROXIMATELY HALF OF THE CLAIMED LOSSES. WELLS FARGO HAS PAID THE AWARD. I DID NOT CONTRIBUTE TO THE PAYMENT.
