IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

 - A "resolved" matter usually includes a disposition wherein no payment is made to the customer or there is no finding of wrongdoing on the part of the Investment Adviser Representative. Such matters generally involve customer disputes.

OUR RECORDS REFLECT THE OPPENHEIMER MUTUAL FUNDS WERE TRANSFERRED INTO THE CLIENT'S ACCOUNT IN OCTOBER 2006. FA HAS STATED THE CLIENT LIKED THE INCOME HE WAS RECEIVING FROM OPPENHEIMER, HOWEVER, DID NOT LIKE THE FLUCTUATING VALUE. FA HAS STATED, SINCE THE CLIENT DIDN'T LIKE THE PRICE FLUCTUATION BUT LIKED THE INCOME, SHE RECOMMENDED THE PURCHASE OF THE CATERPILLAR AND SLM NOTES. CLIENT'S LETTER STATES THE PROPER IRS FORMS WERE NOT FILED CAUSING THE CLIENT A SUBSTANTIAL TAX OBLIGATION. FA HAS STATED WHEN THE CLIENT SOLD THE OPPENHEIMER SHARES IN 2006 SHE INFORMED THE CLIENT THAT HE WOULD RECEIVE A 1099 FROM OUR FIRM. FA HAS ALSO STATED SHE RECOMMENDED THAT THE CLIENT USE A TAX PROFESSIONAL TO PREPARE HIS TAXES BUT BELIEVES THE CLIENT MAY HAVE DONE HIS OWN TAXES THEREBY CREATING THE IRS INQUIRY. AS TO THE NOTE REGARDING THE ANNUITY, THE FA HAS INDICATED THE ANNUITY WAS PURCHASED FROM THE CLIENT'S PREVIOUS FIRM. IT IS OUR UNDERSTANDING THAT A PORTION OF THE ANNUITY WAS INVESTED IN FIXED INVESTMENTS AND THE OTHER PORTION WAS INVESTED IN VARIABLE INVESTMENTS. FA HAS STATED THAT ONCE SHE BECAME FINANCIAL ADVISOR OF RECORD, SHE ATTEMPTED TO GET THE UNDERLYING INVESTMENTS CHANGED BUT WAS TOLD BY THE HARTFORD THAT CHANGES WERE NOT ALLOWED.
