**Allegations:** Myers was named in a customer complaint that asserted the following causes of action: negligence, suitability, breach of contract, breach of fiduciary duty, and negligent misrepresentation. The causes of action relate to Claimant's allegation that Respondents' investment strategy included unsuitable trading in speculative inverse and leveraged exchange traded funds (ETFs), and then Respondents' investment strategy changed to buying and holding one silver ETF for Claimant's entire account for the next six years, devastating Claimant's retirement savings.

Respondents are jointly and severally liable for and shall pay to Claimant the sum of \$50,000.00 in attorneys' fees pursuant to Tex. Civ. Prac. & Rem. Code § 38.001. Respondents are jointly and severally liable for and shall pay to Claimant the sum of \$5,000.00 in expert witness fees. Respondents are jointly and severally liable for and shall pay to Claimant the sum of \$225.00 in costs. Respondents are jointly and severally liable for and shall pay to Claimant the sum of \$300.00 to reimburse Claimant for the non-refundable portion of Claimant's filing fee.
