What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

I affirmatively deny any and all allegations in the claim. The investments at issue comprised a small portion of the customer's portfolio and were well within LPL's concentration guidelines. As planned, they generated significant cash distributions for the customer's portfolio. The customer acknowledged that he understood and accepted the disclosed investment risks in written documents. Ultimately, this matter was settled for a nuisance fee simply to avoid the costs and business disruption of a hearing, I did not contribute to the settlement and continue to deny any wrongdoing.
