### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

IR INDICATED HE EXPLAINED TO CLIENT THAT THE FIRM DID NOT FOLLOW THAT PHILOSOPHY OF INVESTING AND IR RECOMMENDED HOLDING INVESTMENTS FOR THE LONG TERM. IT IS UNDERSTOOD IR WAS NOT PROVIDED WITH INSTRUCTIONS TO SELL THE INVESTMENTS AND DOES NOT RECALL THE TERM "TRAILING STOP" EVER BEING USED. SINCE THE CLIENT PURPORTEDLY GAVE THE INSTRUCTIONS TO IR, CLIENT WOULD HAVE RECEIVED STATEMENTS REFLECTING THE INVESTMENTS BEING HELD IN THE ACCOUNT. IR STATED HE MET WITH THE CLIENT ON JANUARY 9, 2004, AT WHICH TIME THIS SITUATION WAS DISCUSSED AND IR EXPLAINED HE HAD NOT RECEIVED INSTRUCTIONS FROM THE CLIENT TO PLACE THE ORDERS. CLAIM DENIED.
