What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

entered into a monthly installment agreement with the IRS on June 5, 2019. First payment made in July. I thought the matter was settled. Was told to expect a Confirmation letter in 4/5 weeks. I was stunned when I opened an IRS letter around July 17 or 18, and saw that a lien was being imposed, but with a right to a hearing. Then spoke to 3 or 4 IRS reps., who all told me this: You have to appeal. So, I submitted a lengthy appeal dated July 20 (by registered mail). Still hoping for a hearing to make my case.
