## Broker Statement

FA STATED ON 1/10/06, HE REVIEWED THE DETAILS OF THE AMERICAN BALANCED FUND AND EXPLAINED THAT THE MUTUAL FUND HOLDS STOCKS AND BONDS. AS A RESULT OF THIS DISCUSSION AND THE CLIENT'S GOAL TO HAVE A RESTAURANT, FA RECOMMENDED PUTTING \$40,000 IN A SIX-MONTH CD AND INVESTING THE REMAINING \$10,000 INTO THE MUTUAL FUND. IT IS OUR UNDERSTANDING CLIENT AUTHORIZED THE FA TO PROCEED WITH HIS RECOMMENDATION. FA HAS STATED ON 7/17/06 ANOTHER SIX-MONTH CD WAS PURCHASED. IN 10/06, FA INDICATED CLIENT MADE THE DECISION TO BEGIN TRANSFERRING \$7,000/MO ELECTRONICALLY INTO HER EJ ACCT AND HER OBJECTIVE FOR THESE FUNDS WAS INVESTING FOR THE LONG TERM. ACCORDING TO FA, HE AGAIN DISCUSSED INVESTING IN MUTUAL FUNDS AND SPECIFICALLY REVIEWED THE RETURNS, FEES, RISKS AND EXPENSES BEFORE CLIENT AUTHORIZED THE SYSTEMATIC PURCHASE OF THREE FRANKLIN MUTUAL FUNDS EACH MONTH. OUR RECORDS REFLECT THE SYSTEMATIC MUTUAL FUND PURCHASES CONTINUED UNTIL 4/08. IN 6/07, IT IS OUR UNDERSTANDING CLIENT'S INVESTMENT OBJECTIVES HAD CHANGED AND AS A RESULT MUTUAL FUNDS WERE PURCHASED WITH CD PROCEEDS. FA STATED CLIENT WAS VERY EMOTIONAL ABOUT HER ACCOUNT IN 6/08. FA INDICATED HE RECOMMENDED LIQUIDATING THE MUTUAL FUNDS; HOWEVER, CLIENT MADE THE DECISION TO CONTINUE HOLDING THE FUNDS. WHILE WE UNDERSTAND CLIENT'S DISAPPOINTMENT IN THE



PERFORMANCE OF HER ACCOUNT, WE HAVE BEEN EXPERIENCING TUMULTUOUS MARKET CONDITIONS AND FLUCTUATION IS A RISK ASSOCIATED WITH INVESTING. WHILE TRADE CONFIRMATIONS AS WELL AS ACCOUNT STATEMENTS WOULD HAVE MAILED TO THE CLIENT'S HOME ADDRESS REFLECTING ALL ACCOUNT ACTIVITY, OUR RECORDS ALSO REFLECT CLIENT HAS BEEN ENROLLED IN ACCOUNTLINK SINCE 2/15/06 AND SHE HAS BEEN ABLE TO VIEW HER ACCOUNT ONLINE. AT THIS TIME, WE RESPECTFULLY DENY CLIENT'S REQUEST TO REIMBURSE THE LOSSES ASSOCIATED WITH THE MUTUAL FUNDS HELD IN HER ACCOUNT.
