<b>Allegations:</b>	The former client made two written complaints against Mr. Taylor, one with the CFP Board and another with the SEC. Both allege that in January 2022, Mr. Taylor misled him about the potential risk of loss of the investments recommended to him, which included the use of protective puts as a hedge against market decline. Specifically, the former client alleged that Mr. Taylor told him that "the most the account would drop in value was 5% and showed [him] numerous brochures indicating such" and that Mr. Taylor misled him about the risks involved in investing in protective options.

**Broker Statement**

Mr. Taylor vehemently denies the substance of the former client's allegations or that he engaged in any wrongdoing in this matter. The former client demonstrated a strong financial acumen, indicated that he had advanced knowledge about financial products, and stated that he was willing to accept an up to 20% loss of principal in the short term. Mr. Taylor extensively discussed the protective put strategy and particularly its risks with the former client starting at their first in-person meeting, and at several other times thereafter. After the first meeting, the former client indicated that he conducted his own research into protective puts and options in general and concluded that he wished to pursue the strategy. Mr. Taylor therefore believed the former client understood the strategy and the inherent risks before choosing to execute it. The accusations that Mr. Taylor misled the former client about the risk of his investment and that the risk of loss was limited to 5% are baseless and in stark contrast to the documents Mr. Taylor delivered to him. Those documents clearly identify the risks involved in the strategy, and that investing in securities involves the risk of loss that he should be prepared to bear. Mr. Taylor strongly believes that his recommendations to the former client were given in full compliance with applicable standards of conduct.
