What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: NC RESIDENT STATED THAT HE WAS MISLED INTO BELIEVING THAT HIS WACHOVIA PREFERRED STOCK POSITION WAS WORTHLESS. WHEN VALUE INCREASED TO \$68,000 CLIENT SOLD BECAUSE HIS FINANCIAL ADVISOR SUGGESTED HE SELL AS THE POSITION MIGHT GO DOWN AND BECOME WORTHLESS AGAIN. THE WACHOVIA PREFERRED THE CLIENT OWNED HAS INCREASED IN PRICE AND HE HAS ASKED FOR THE POSITION TO BE REINSTATED BASED ON INCORRECT INFORMATION PROVIDED BY FINANCIAL ADVISOR. THE COST TO REINSTATE THE POSITION WOULD BE ABOUT \$68,248 BASED ON MARKET CLOSE ON 10/27/08.
