What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

Allegations:	Without admitting or denying the findings, Shehu consented to the sanctions and to the entry of findings that he electronically signed his registered representative partner's name on account opening and discretionary authority agreements. Shehu's member firm required both representatives of record to sign new account and discretionary authority agreements. When his partner was unavailable, Shehu would electronically sign for his partner and submit the documents to the firm. Although Shehu believed he had permission to sign documents on behalf of his partner, he failed to alert the firm he was doing so and falsified his partner's signature on dozens of documents. After the firm began investigating his falsifications, Shehu asked his partner to falsely claim that he had electronically signed the documents. Shehu also falsely stated on two compliance questionnaires that he had not signed another person's signature on a document.
