**Broker Statement** The client's stated investment objective is long-term growth with a long-term time



horizon. Their risk tolerance is Moderate. A variable annuity was selected as the investment due to the fact that the foundation was a charitable entity, and a death benefit and lifetime income rider were suitable for the entity. In my on going meetings with the client, they did not express a desire to change their risk tolerance, time horizon, or investment objective. The investment selected for the variable annuity was the JNL Vanguard Moderate growth asset allocation model to match the investment objective, time horizon, and risk tolerance.

Although it's frustrating to see a decline in the market value of investments during turbulent times such as we have seen these past few years. When the complaint was reviewed by the broker-dealer, they confirmed with Jackson that there were no unrealized losses in the contract.

It is my understanding that if Jackson National would have honored the client's request to change ownership of the annuity contract initially from the Foundation to an individual, the complaint would have never been filed. I offered to help the client facilitate the change in ownership but they contacted Jackson National on their own. Jackson National told the client on more than one occasion that a Corporate Resolution was needed to change ownership. There never was a Corporate Resolution created for the Foundation and Jackson National opened the contract without a Corporate Resolution. My Broker Dealer has contacted Jackson National and they have since changed ownership on the contract from the foundation to the individual.
