In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

### Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

I DID NOT ENGAGE [CUSTOMER] AS A CLIENT AT EITHER PAINE WEBBER OR MORGAN STANLEY. ANOTHER FINANCIAL CONSULTANT WAS NAMED IN THE COMPLAINT. I WAS NOT NAMED. THERE IS A FOUR YEAR PERIOD FROM MY DEPARTURE TO THE TIME OF THE COMPLAINT.WE REPEATEDLY ASKED MERRILL LYNCH TO FORWARD SUPPORTING DOCUMENTS FOR THIS COMPLAINT. MERRILL LYNCH HAS FAILED TO PROVIDE NEITHER THE COMPLAINT LETTER NOT THE SUPPORTING INFORMATION DIRECTLY TO ME OR MORGAN STANLEY AFTER REPEATED REQUESTS.
