What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

IN JULY 2008, THE INCOME ACCESS RIDER RESET AT CURRENT MARKET VALUE AT ANNIVERSARY DATE, BELOW THE AMOUNT OF THE FIRST YEARS CONTRIBUTIONS INTO THE ACCOUNT. CLIENT DID NOT RECEIVE ALL INITIAL DEPOSITS AS DESCRIBED IN PACIFIC INCOME ACCESS RIDER. CLIENT BELIEVED ALL OF HER FIRST YEAR DEPOSIT WOULD BE PROTECTED, WHEN IN FACT THEY WERE NOT.

SAWICKI. IT WAS KNOWN AT THE MEETING THE SOURCES OF CONTRIBUTION TO THE CONTRACT WERE GOING TO OCCUR AT VARIOUS STAGES DURING THE FIRST YEAR OF THE CONTRACT. [CUSTOMER] AND MR. SAWICKI LEARNED OF A "60 DAY WINDOW" FROM CONTRACT ANNIVERSARY DATE FOR ALL DEPOSITED TO BE COUNTED FOR THE PROTECTED PAYOUT BASE IN JULY 2008. THIS FACT WAS NOT DISCLOSED TO [CUSTOMER] DURING THE PRESALE MEETING. [CUSTOMER] BELIEVED ALL OF HER FIRST YEAR DEPOSIT WOULD BE PROTECTED, WHEN IN FACT THEY WERE NOT.
