What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: ACCORDING TO STATE OF IL, CLIENTS HAVE ALLEGED THERE WERE ONLY INTRODUCED TO "MODERATELY AGGRESSIVE FUNDS", RATHER THAN A "FIXED OR MORE CONSERVATIVE INCOME" DESPITE THE FACT THE CLIENT WAS 60 YEARS OLD AND ONLY 2 YEARS FROM RETIREMENT. CLIENTS CLAIMED THEY CONVEYED THEIR CONCERN TO IR, JIM GLENN, WHO PERSUADED THEM TO HOLD THEIR POSITIONS AND NEVER SUGGESTED ANY ALTERNATIVE INVESTMENTS. CLIENTS CLAIM AS A RESULT THEY HAVE INCURRED LOSSES OF \$70,000.

DOCUMENTATION ADDRESSING THE CLIENTS CONCERNS. IR STATED THEIR PORTFOLIO IS COMPRISED OF BOTH AAA INSURED BONDS AS WELL AS THE RECOMMENDED MUTUAL FUNDS. IR STATED THE CLIENT AT NO TIME INDICATED HE WAS RETIRING IN 2 YEARS AND THEY SPECIFICALLY DISCUSSED THE NEED TO KEEP THESE FUNDS INVESTED FOR AT LEAST A 5 YEAR PERIOD. CLIENTS WOULD HAVE BEEN PROVIDED WITH TRADE CONFIRMATIONS AND PROSPECTUSES ON THE FUNDS AND BOTH CLIENTS EXECUTED THE MUTUAL FUND PURCHASE OF "B" SHARES ACKNOWLEDGMENT LETTER. IR STATED THE CLIENTS PURCHASED THE B SHARES AGAINST HIS ADVICE AND WERE MADE FULLY AWARE OF THE CDSC FEES ASSOCIATED WITH THE B SHARE FUNDS. IR STATED DURING HIS INITIAL ACCOUNT REVIEWS WITH THE CLIENTS HE CONTINUED TO EXPRESS THE NEED TO HOLD THESE INVESTMENTS FOR THE LONG TERM AND EXPRESSED TO THE CLIENT THE FUNDS HAD NOT BEEN HELD LONG ENOUGH TO ALLOW THE FUNDS TO PERFORM. IR STATED IN JUNE 2001 HE DID DISCUSS EXCHANGING SOME OF THE FUNDS TO ANOTHER PUTNAM FUND AND THE EXCHANGE WAS PROCESSED AT THE CLIENT'S INSTRUCTIONS. APPEARS THE INVESTMENTS WERE IN LINE WITH THE ACCOUNTS STATED INVESTMENT OBJECTIVES AND WOULD HAVE RECEIVED CUSTOMER ACCOUNT STATEMENTS REFLECTING THE ASSET CATEGORY AND ESTIMATED VALUE OF THE FUNDS.
