What is included in a IAPD report?

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

THIS COMPLAINT WAS WITHOUT MERIT. THE CLIENT'S CLAIM OF UNAUTHORIZED TRADING OF OPTIONS IS FALSE, AS WE RETAIN THE DOCUMENT IN OUR FILES, WHICH HE SIGNED, AUTHORIZING OPTION TRADING IN A DISCRETIONARY ACCOUNT, AND WAS THOROUGHLY DISCUSSED WITH THE CLIENT MULTIPLE TIMES. HIS CLAIM OF NON-DISCLOSURE OF FEES IS A RESULT OF AN OPERATIONAL ISSUE WITHIN OUR MANAGED ACCOUNT, WHICH CHARGED HIM FEES, UNKNOWN TO ME. UPON DISCOVERING THIS ISSUE, I IMMEDIATELY BEGAN WORKING WITH UBS TO HAVE THEM CREDIT THOSE FEES BACK TO THE CLIENT. UNFORTUNATELY, BEFORE IT WAS RESOLVED, THE CLIENT FILED AN UNNECESSARY COMPLAINT WHICH REQUIRED THIS FILING. THESE FEES WERE NOT PART OF ANY SALES PLOY, AND I DID NOT CHARGE, NOR DID I RECEIVE ANY COMPENSATION FOR THESE FEES. THIS SETTLEMENT WAS MADE BY UBS TO REIMBURSE THE CLIENT FOR THESE CHARGED FEES AND NOT BASED ON ANY WRONGDOING ON MY PART WHATSOEVER. OBVIOUSLY, SINCE I RECEIVED NO COMPENSATION, I ALSO DID NOT PARTICIPATE IN THE SETTLEMENT, AND DID NOT OWE THE CLIENT ANY REIMBURSEMENT.
