What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement NBSC FOUND NO EVIDENCE OF ALLEGED UNAUTHORIZED MONEY TRANSFER. CLIENTS AGREED DURING PHONE CONVERSATION THAT BANK ACCOUNT FUNDS WERE NOT MISAPPROPRIATED, BUT RATHER WERE MOVED FROM DECEASED MOTHER'S ACCOUNT INTO NEW SURVIVOR ACCOUNT AS REQUIRED BY BANK PROCEDURE. Allegations: CLIENT MET WITH RR ON TWO OCCASIONS TO DISCUSS INVESTMENT OPTIONS FOR PORTFOLIO OF VARIOUS EQUITIES, MUTUAL FUNDS, AND ETFs. AT THE SECOND MEETING, CLIENT COMPLETED ALL REQUIRED PAPERWORK TO PURCHASE A FIXED ANNUITY. THE CLIENT ALLEGED THAT SHE DID NOT AUTHORIZE THE SELL OF THE SECURITIES TO FUND THE ANNUITY PURCHASE. THE CLIENT TERMINATED THE ANNUITY CONTRACT WITHIN THE FREE LOOK PERIOD PROVIDED BY THE ANNUITY COMPANY. ALTHOUGH IT APPEARED THAT THE CLIENT AUTHORIZED THE ANNUITY PURCHASE, THE CLIENT'S POSITIONS WERE RESTORED WITH ALL LOSS BEING TAKEN BY THE FIRM.
