What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement OUR RECORDS REFLECT THE TRANSACTIONS WERE EFFECTED IN ACCOUNTS ON 10/31/05 AND 11/1/05 AS RESULT OF DISCUSSIONS BETWEEN CLIENT AND IR. CONTRARY TO CLIENT'S COMMENTS DURING PHONE CONVERSATION OF 1/20/06, THE DISCUSSIONS REGARDING THE PROPOSAL DID NOT OCCUR OVER THE PHONE BUT IN FACE-TO-FACE



CONVERSATIONS WHILE IN FLORIDA AS IR WAS WITH CLIENT IN FLORIDA FOR A TIME TO ASSIST WITH HURRICANE CLEAN-UP. IR INDICATED THE CHANGES WERE SUGGESTED BECAUSE CLIENT OWNED MANY OF THE SAME STOCKS IN PERSONAL ACCOUNTS AS WELL AS IN PARENT'S TRUST ACCOUNT(S) AND HAD BEEN CONCERNED WITH MARKET PERFORMANCE OVER THE PAST FEW YEARS. IR STATED CLIENT RETURNED FROM FLORIDA ON OR ABOUT 11/10/05 AND IR SPOKE TO CLIENT SEVERAL TIMES PRIOR TO THE RECEIPT OF LETTER DATED 11/25/05 AND CLIENT EXPRESSED NO DISSATISFACTION WITH THE CHANGES. AS A RESULT OF THE CHANGE IN OBJECTIVES, ACCOUNTS WERE UPDATED TO REFLECT INCOME AND AGGRESSIVE INCOME INVESTMENT OBJECTIVES.
