IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

MERRILL LYNCH AND THE FINANCIAL ADVISOR DENY THE ALLEGATIONS. THE CUSTOMER'S WITHDRAWAL OF MONEY FROM HER ACCOUNT AS WELL AS MARKET ACTION RESULTED IN HER MARGIN DEBIT. THE CUSTOMER AGREED TO SELL SHARES OF A STOCK TO MEET HER FIRST MARGIN CALL. HER FINANCIAL ADVISOR ATTEMPTED TO CONTACT HER SEVERAL TIMES REGARDING SUBSEQUENT MARGIN CALLS, BUT THE CUSTOMER FAILED TO RESPOND. PURSUANT TO THE MARGIN AGREEMENT WHICH THE CUSTOMER SIGNED, THE FIRM PROPERLY LIQUIDATED SUFFICIENT SECURITIES TO COVER THE ADDITIONAL FUNDS DUE. THE CUSTOMER WAS INFORMED OF THE USES OF MARGIN AND THE NATURE OF BORROWING AGAINST THE VALUE OF SECURITIES IN HER ACCOUNT.
