Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement

THE CLIENTS WITHDREW THEIR CLAIMS. A.G. EDWARDS & SONS, INC SETTLED WITH THE CLIENTS FOR \$20,000. CLAIMANTS IN WRITING, HAVE WITHDRAWN ANY COMPLAINTS THEY LODGED AGAINST ME. THE ARBITRATION MATTER SETTLED AFTER IT COMMENCED AS A RESULT OF A BUSINESS DECISION MADE BY AG EDWARDS. [CUSTOMER] WAS THE ONLY WITNESS WHO TESTIFIED DURING THE ARBITRATION PRIOR TO SETTLEMENT. AT A BREAK DURING [CUSTOMER'S] CROSS-EXAMINATION, HIS ATTORNEY APPROACHED A.G. EDWARDS TO DISCUSS SETTLEMENT. IF THE CASE HAD NOT SETTLED WHEN IT DID, IT WAS APPARANT THE ARBITRATION WOULD EXTEND TO ADDITIONAL HEARING DATES IN LATE 1998 OR 1999. AG EDWARDS ACCEPTED THE CLIENTS SETTLEMENT OFFER AND DETERMINED THE AMOUNT WAS LESS THAN WHAT IT WOULD COST AG EDWARDS TO DEFEND THE ARBITRATION.
