IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

CUSTOMER BECAME A CLIENT IN MARCH OF 2000. SHE REQUESTED AN AGGRESSIVE INVESTMENT STRATEGY. AFTER REVIEWING HER FINANCIAL SITUATION I REQUESTED THAT SHE SIGN A DISCLAIMER FORM SPECIFICALLY ACKNOWLEDGING THAT SHE HAD REQUESTED AN AGGRESSIVE PORTFOLIO AND THAT SHE UNDERSTOOD SHE WAS TAKING MORE RISK THAN I HAD INITIALLY RECOMMENDED AND MORE RISK THAN MIGHT BE APPROPRIATE FOR SOMEONE HER AGE. I LEFT MERRILL LYNCH IN JULY OF 2001. THE MARKET CONTINUED TO GO DOWN AND CUSTOMER FILED HER COMPLAINT IN OCTOBER OF 2002, 1 YEAR AND 3 MONTHS AFTER I HAD LEFT AND HAD NO CONTACT WITH HER. UPON INVESTIGATION THE COMPLAINT WAS FOUND TO BE WITHOUT MERIT AND WAS DENIED.
