APPROXIMATELY ONE YEAR LATER, AFTER FIRST CLAIMING THAT THE \$250 FEE WAS IMPROPERLY CHARGED (IT WAS NEVER CHARGED), SHE THEN CLAIMED SHE NEVER SIGNED THE DISTRIBUTION FORM. I DID NOT SIGN ANY FORM WITH THE CLIENT`S NAME AND WHEN I RECEIVED A \$250 DISTIBUTION FORM FROM THE CLIENT IT WAS SIGNED.
