### Broker Statement

I RESPECTFULLY DISAGREE WITH THE ARBITRATION PANEL'S FINAL DECISION. THE CLIENT'S CONCENTRATION IN TECHNOLOGY AND INFORMATION SECURITIES WAS A REFLECTION OF HER OWN INTEREST AND WILLINGNESS TO ASSUME A GREATER DEGREE OF RISK IN THE PURSUIT FOR POTENTIAL GAINS DESPITE BEING WARNED OF THE RISKS WITHIN THE MORGAN STANLEY ACCOUNTS. DOCUMENTATION PRODUCED AT THE ARBITRATION SHOWED THAT SHE INDEPENDENTLY AND ACTIVELY TRADED IN THE SAME SECURITIES THROUGH A SEPARATE ONLINE DISCOUNT BROKERAGE ACCOUNT AND IN HER SELF-DIRECTED 401(K) THAT SHE ALLEGED WERE UNSUITABLE DURING THE ARBITRATION. AT THE TIME OF THIS RELATIONSHIP, THE CLIENT DID NOT DISCUSS WITH ME HER OUTSIDE AND INDEPENDENT INVESTMENT ACTIVITIES IN THESE OTHER ACCOUNTS.
