What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

In July 2016, I met with an elderly couple who sought guidance regarding their retirement strategy because they were concerned that they were invested too aggressively. After preparing a retirement plan, I presented a proposal to reduce their risk, increase their income, provide principal protection, and keep the proceeds from the sale of their home separate in a savings account. They agreed with the plan, and several months later, their daughter and son-in-law wanted to meet to discuss the changes in her parents' portfolio. The meeting concluded positively with the questions answered to their satisfaction. However, in 2017, Wells Fargo received a complaint that alleged I used high-pressure sales tactics, invested their home sale proceeds, and invested the clients in an annuity with excessive fees, all of which I knew to be untrue. After Wells Fargo's review of the allegations, I was informed that they did not find any wrongdoing on my part but made a business decision to settle the claim.
