IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement

THIS NOTE WILL EXPLAIN THE CIRCUMSTANCES BEHIND MY RECENT DISCHARGE FROM MORGAN STANLEY SMITH BARNEY. I HAD FULL AUTHORITY TO TRADE FOR CERTAIN CLIENTS AS I WAS AN FA USING THE FIRM-APPROVED FULLY DISCRETIONARY PORTFOLIO MANAGEMENT PROGRAM. IN LATE 2010 I ACCIDENTALLY OVERRODE AN AUTOMATIC SOFTWARE BLOCK IN ORDER TO PLACE EIGHT TRADES IN A SINGLE ETF. I WAS UNDER THE MISTAKEN BELIEF THAT THERE WAS FULL AUTHORIZATION FOR THESE TRADES BECAUSE THE ETF WAS ON AN APPROVED LIST. ALL OF THE ACCOUNTS FOR WHICH THE TRADES WERE PLACED WERE EACH IN THE FIRM-APPROVED FULLY DISCRETIONARY



PORTFOLIO MANAGEMENT PROGRAM. I RECEIVED NO FINANCIAL BENEFIT FOR THESE TRADES AS THESE ACCOUNTS WERE FEE BASED, NONE WERE COMMISSION BASED. I HAVE NO PRIOR INCIDENTS IN MY CAREER ON MY U4 DURING THE 10+ YEARS WITH MSSB AND 15+ YEARS IN THE INDUSTRY. DESPITE THESE FACTS, MSSB DECIDED THAT I HAD BROKEN COMPANY POLICY WHICH RESULTED IN MY DISCHARGE.
