**Broker Statement**

I DON'T BELIEVE THIS WAS A FORMAL COMPLAINT FROM CLIENT. IF SO, I SHOULD HAVE BEEN MADE AWARE OF THE COMPLAINT, BEEN GIVEN A COPY OF THE WRITTEN COMPLAINT AND GIVEN AN OPPORTUNITY TO RESPOND. I TOOK THIS ACCOUNT OVER FROM ANOTHER ADVISOR IN MID 2009 (UPON MY RETURN TO BBVA) AFTER THE CLIENT HAD LOST A SIGNIFICANT AMOUNT IN THE MARKETS DURING 2008. THE CLIENT WAS OVER 70% EQUITIES WITH A MARKET VALUE OF ABOUT \$495,000. GIVEN THE SIZE OF THE PORTFOLIO, I RECOMMENDED MOVING IT TO BROKERAGE AND STRUCTURING A MUCH MORE CONSERVATIVE PORTFOLIO OVER A PERIOD OF TIME. I WORKED ON THIS ACCOUNT FROM MID 2009 UNTIL ABOUT OCTOBER 2011. AT THAT TIME, THE PORTFOLIO HAD GROWN TO OVER \$600,000 AND HIS EQUITY EXPOSURE WAS LESS THAN 5%. THE "EQUITY" MUTUAL FUND THAT I BELIEVE IS BEING REFERENCED IS ACTUALLY A SHORT TERM "BOND" FUND. ISSUE WITH THIS CLIENT WAS OVER CONTRIBUTIONS MADE TO ONE OF HIS QUALIFIED ACCOUNTS. HIS WIFE HAD DEPOSITED MONEY INTO A REGULAR IRA OVER A COUPLE OF YEARS INSTEAD OF PUTTING IT INTO HER SEP IRA. WE WORKED WITH HER AND THEIR ACCOUNTANT TO CORRECT THE ISSUES, BUT SHE WAS ALWAYS VERY ABRASIVE AND I GOT TIRED OF THE WAY SHE WAS TREATING EVERYONE SO I SUGGESTED THAT THEY MOVE THE ACCOUNT TO ANOTHER ADVISOR.
