What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Broker Statement	<p>No tribunal has found any that I committed any wrongdoing with respect to these customers or their investments. Claimants originally filed a separate claim in arbitration against their former broker, who sold them two non-traded REITs, alleging the investments were unsuitable. That case was dismissed with prejudice. Unsatisfied, they reframed a subsequent claim to focus on me. I did not sell the investments to the customers; I merely inherited their accounts, which were already invested in the illiquid securities. I contend that I complied with all fiduciary, ethical, and legal obligations with respect to these customers, especially given the dearth of opportunities available with respect to their REITs. I consistently provide tailored, financial and investment advice to my customers, under a fiduciary standard of care and loyalty, and these customers were no different. I understand that LPL settled the matter for a nominal sum, substantially less than the cost of defending the arbitration through hearing. I did not contribute any money towards the settlement. I understand that LPL has made no admission of wrongdoing, and disclaims any and all liability with respect to any and all assertions or allegations arising out of the arbitration.</p>
