THE CLIENT STATES HE INFORMED CHATHAM HE DID NOT FOLLOW MUTUAL FUNDS CLOSELY AND HE WOULD RELY ON CHATHAM'S JUDGEMENT TO TO SELECT FUNDS THAT WERE NOT SO VOLATILE WITH GOOD TRACK RECORDS. THE CLIENT STATES CHATHAM HAS PLACED HIM IN FOUR AGGRESSIVE FUNDS WHICH HAVE DECLINED IN VALUE. THE CLIENT STATES CHATHAM HAS FAILED TO FOLLOW THE GUIDANCE THE CLIENT GAVE HIM. THE CLIENT ALSO STATES HE WAS MISINFORMED ABOUT WHAT COMMISSIONS WOULD BE CHARGED ON THE MUTUAL FUNDS AND SOME STOCK PURCHASES. THE CLIENTS UNREALIZED LOSSES EXCEED \$5,000.
