What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations: In November 2017, client transferred shares to firm in kind with the intent to reallocate transferred shares into a new portfolio. It was discovered in August 2018, that reallocation did not occur. To correct this, the reallocation was completed. This resulted in sells occurring in the client's account which created a capital gains tax situation for client. Client alleges she was not aware that sells would take place and of the tax consequences that the sells would create.
