**Broker Statement**

Representative denies the complaint in its entirety. Customer invested in a formulaic trending money manager, that fully disclosed the active management strategy that involved monthly trading. In addition, all asset management fees were fully disclosed to the customer. The account at question is a managed advisory account, which means that commissions were NOT charged on any trade in the customer's account. After thorough review, this complaint is entirely denied.
