IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

Broker Statement Claimant was a sophisticated ultra-high net worth individual with extensive investment and financial services industry experience. Claimant specifically requested recommendations to invest in alternative private notes to generate additional income for his portfolio. Respondent conducted extensive due diligence on the Note Issuer, and the Claimant conducted his own review of the Note offering documentation, including financial and risk disclosures and participated in a due diligence call directly with the CEO of the fund company. Claimant chose to invest in the offering and signed subscription paperwork acknowledging the risks associated with investing in an alternative private note. The arbitrator found no securities law violation and no breach of fiduciary duty on the part of the Respondent; Claimant received an award plus interest based upon arbitrator's finding that Claimant might have made a different decision if MMA had provided additional information beyond the private placement memorandum supplement and extensive due diligence materials provided.
