IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

Allegations:	THE INSURANCE COMMISSIONER ALLEGED THAT REPRESENTATIVE KNOWINGLY SUBMITTED ANNUITY APPLICATIONS FOR TWO WASHINGTON CONSUMERS WHICH CONTAINED MISREPRESENTATIONS TO AN INSURANCE COMPANY. SPECIFICALLY, THE "SIGNED AT" SECTIONS OF THE ANNUITY APPLICATIONS FALSELY INDICATED THAT THE APPLICATIONS WERE SIGNED IN GILBERT, ARIZONA. THE CONSUMERS WHO SIGNED THE ANNUITY APPLICATIONS IN WASHINGTON (WHERE THE ANNUITY PRODUCT WAS NOT APPROVED FOR SALE) INDICATED THAT THEY DID NOT FILL OUT THE DATE (APRIL 11, 2005) AND "SIGNED AT" SECTIONS WHICH WERE COMPLETED IN HANDWRITING THAT APPEARED MARKEDLY DIFFERENT FROM THEIR SIGNATURES.
