**Allegations:** CLIENTS ALLEGE TALBERT ENCOURAGED THEM TO PURCHASE SHARES OF COMPAQ (CPQ) ON MARGIN IN APRIL 1999, STATING HE BELIEVED THE STOCK WOULD BE PROFITABLE AND THE PRICE PER SHARE WOULD RISE TO \$60.00 IN A SHORT TIME PERIOD. CLIENTS STATE TALBERT INFORMED THEM THE INTEREST RATE TO BORROW FUNDS FROM THE FIRM WOULD BE COMPARABLE TO THE INTEREST RATE THEY WERE EARNING ON THEIR SAVINGS. ALSO, ALLEGE TALBERT DID NOT INFORM THEM OF THE RISKS ASSOCIATED WITH PURCHASING STOCK ON MARGIN. CLIENTS DO NOT MAKE A SPECIFIC CLAIM. HOWEVER, THE UNREALIZED LOSSES WITH CPQ ARE APPROXIMATELY \$6,400.00.

TALBERT STATES, AT THE TIME OF PURCHASE, THE CLIENTS WERE INFORMED OF THE OPTIONS FOR PAYING FOR THE PURCHASE (CASH OR MARGIN) AND WERE ALSO INFORMED OF THE INTEREST CHARGES/RATES ASSOCIATED WITH MAINTAINING A MARGIN BALANCE. TALBERT FURTHER STATES HE MADE NO GUARANTEES AS TO THE PERFORMANCE OF THE STOCK. CLIENTS PURCHASED ADDITIONAL SHARES OF CPQ ON 4/16/99. TALBERT INDICATES HE CONTACTED THE CLIENTS SEVERAL TIMES DURING THE LAST TWO YEARS AND PERFORMED PORTFOLIO REVIEWS AT WHICH TIME THE PERFORMANCE OF CPQ WAS DISCUSSED. TALBERT FURTHER INDICATES HE MAKES A REGULAR PRACTICE OF INFORMING CLIENTS OF THE POTENTIAL FOR MARGIN CALLS WHEN MAINTAINING A LOAN BALANCE IN AN ACCOUNT. AT THE TIME OF PURCHASE, THE CLIENTS WOULD HAVE RECEIVED TRADE CONFIRMATIONS. IN ADDITION, THEY HAVE RECEIVED STATEMENTS WHICH PROVIDE INFORMATION REGARDING THE ACTIVITY IN THE ACCOUNT (INCLUDING MARGIN ACTIVITY). BASED ON OUR REVIEW, ANY CLAIMS MADE IN REGARDS TO THIS SITUATION WOULD BE RESPECTFULLY DENIED.
