THE SECURITIES DIVISION ALLEGES THAT AFTER ENTERING INTO A CONSENT ORDER WITH SMITH ON NOVEMBER 19, 2012 TO SETTLE ALLEGATIONS THAT SMITH FAILED TO REGISTER AS AN INVESTMENT ADVISER FOR OVER ELEVEN YEARS, SMITH CONTINUED TO PROVIDE INVESTMENT ADVISORY SERVICES FOR COMPENSATION FROM HIS RESIDENCY IN BELLINGHAM, WASHINGTON WITHOUT REGISTRATION BETWEEN NOVEMBER 19, 2012 AND JANUARY 14, 2015. THE SECURITIES DIVISION FURTHER ALLEGES THAT BLAIR SMITH FAILED TO MAINTAIN ALL THE BOOKS AND RECORDS REQUIRED OF INVESTMENT ADVISERS, INCLUDING CLIENT CONTRACTS. THE RESPONDENT NEITHER ADMITTED NOR DENIED THE ALLEGATIONS, BUT AGREED TO CEASE AND DESIST FROM VIOLATING THE INVESTMENT ADVISER REGISTRATION PROVISION OF THE SECURITIES ACT OF WASHINGTON, AND TO PAY A FINE OF \$15,000. THE RESPONDENT WAIVED



HIS RIGHT TO A HEARING AND TO JUDICIAL REVIEW OF THE MATTER.
