IAPD Information About Representatives

IAPD offers information on all current-and many former representatives. Investors are strongly encouraged to use IAPD to check the background of representatives before deciding to conduct, or continue to conduct, business with them.

What is included in a IAPD report?

IAPD reports for individual representatives include information such as employment history, professional qualifications, disciplinary actions, criminal convictions, civil judgments and arbitration awards.

It is important to note that the information contained in an IAPD report may include pending actions or allegations that may be contested, unresolved or unproven. In the end, these actions or allegations may be resolved in favor of the representative, or concluded through a negotiated settlement with no admission or finding of wrongdoing.

Where did this information come from?

The information contained in IAPD comes from the Investment Adviser Registration Depository (IARD) and FINRA's Central Registration Depository, or CRD, (see more on CRD below) and is a combination of:

- information the states require representatives and firms to submit as part of the registration and licensing process, and
- information that state regulators report regarding disciplinary actions or allegations against representatives.

How current is this information?

Generally, representatives are required to update their professional and disciplinary information in IARD within 30 days.

This section provides information regarding a customer dispute that was reported to the Investment Adviser Registration Depository (IARD) by the Investment Adviser Representative (IAR), an investment adviser and/or securities firm, and/or a securities regulator. Reporting Source: Individual

Employing firm when activities occurred which led to the complaint: Mutual of Omaha Investor Services, Inc.

Allegations: Client alleged representative and product sponsor, placed trades in January 2021 rather than by year end 2020 as instructed causing tax implications. Client further alleged the representative and product sponsor were explicitly told to discontinue trade activity within the managed account and that client removed discretionary authority. Client indicates trades continued causing tax implications for 2021. Client also alleged delays in transferring the account and receipt of cost basis information on the part of product sponsor. Client was advised MOIS and MOIS representative do not have discretionary authority or the ability to place trades in accounts held at the product sponsor and managed by third-party money manager. Representative took necessary steps to communicate the requested 2020 trades and informed client when trades were not completed. Ultimately the trades were reversed. Representative indicates she had multiple conversations with the client regarding the managed accounts and was informed of third-party money manager's trading authority. No mishandling on the part of the representative was identified.
