Total combined realized and unrealized client losses are estimated to be in excess of \$2 million. As part of the settlement, Heritage Wealth Management is required to provide an accounting for all losses. Full restitution was ordered, but partially waived based on demonstrated inability to pay and other conditions, including the payment of \$100,000 on a pro rata basis. All fines and restitution payments apply to respondents collectively.
