NY SUPREME COURT TRO ENTERED 5/15/2007 VACATED/REPLACED BY NASD ARBITRATION PANEL ON 05/31/2007 WITH AN ORDER THAT REQUIRES MR. WERTHEIM TO RETURN CERTAIN DOCUMENTS TO WSA AND ALLOWS HIM TO SOLICIT WSA CLIENTS AS LONG AS HE MAINTAINS HIS PRINCIPAL PLACE OF BUSINESS MORE THAN 50 MILES FROM WSA. MR. WERTHEIM IS COMPLYING WITH THE NASD ORDER. CLAIMANT WSA REQUESTED COMPESATORY DAMAGES OF \$649,370. AND ATTORNEYS FEES OF \$158,957. AFTER CONSIDERING PLEADINGS, TESTIMONY AND EVIDENCE PRESENTED AT THE HEARING AND POST HEARING SUBMISSIONS, THE FINRA PANEL ORDERED MR. WERTHEIM TO PAY ONLY COMPENSATORY DAMAGES IN THE AMOUNT OF \$26,967.64. THE PANEL ALSO DETERMINED THAT THE MAY 31, 2007 INJUNCTIVE ORDER EXPIRED BY ITS TERMS ON DECEMBER 15, 2997
