What is included in a IAPD report?

Where did this information come from?

Clients were aware that they were in a cash position from inception as evidenced on their statements each month from April 2020 to the date of the allegation October 2020. From inception the clients and I agreed that they would be placed in protected cash until instructions were given to invest in the stock market. Clients and I had several phone conversations between April and June. At no time did they give instructions to invest in the stock market. They remained in protected cash for four months after my retirement/resignation from my prior firm, only then did the allegations come forth. The firm decided to settle this matter without finding any wrongdoing on my part and without any monetary contribution from me.
